

## RESOLUTION IN SUPPORT OF SAN FRANCISCO SMALL BUSINESSES

WHEREAS, From May 2nd to May 6th, 2022, San Francisco celebrated Small Business Week, highlighting our strong vibrant small business community that collectively makes up 93% of the businesses in San Francisco, supporting more than 364,000 jobs; and

WHEREAS, The toll of the COVID-19 Pandemic greatly impacted our small businesses with the loss of revenue from tourism, conventions, office workers; increases in costs due to scarce labor, rising inflation, and new workplace COVID-19 requirements; and additional impacts such as increases in vandalism, theft, burglaries, and the accumulation of hundreds of millions of dollars in unpaid rent; requiring San Francisco to reimagine downtown to be a vibrant attraction for people and small businesses; and

WHEREAS, The California Democratic Party has committed to support small businesses as demonstrated throughout the [Business and Economy Issue](#) of the Party's Platform, including, but not limited to, such measures as expansion of mentorship, after-school care workforce development, and microloan programs; promotion and guarantee of low-interest small business loans; promotion and expanded access to capital for underserved groups of color; and policies protecting businesses from organized retail crime and vandalism; now, therefore, be it

RESOLVED, That the San Francisco County Central Committee celebrates and acknowledges the important contribution made by our small businesses; encourages San Franciscans to support our local small businesses; and encourages all City agencies to use their authority to assist small businesses so they may thrive and continue to be the foundation of our local economy; and be it

FURTHER RESOLVED, That this Resolution be transmitted to the Office of the Mayor, the Members of the Board of Supervisors, the Office of Economic and Workforce Development, and the Small Business Commission.

## **RESOLUTION IN SUPPORT OF SJR 13, OHLONE TRIBAL RECOGNITION**

WHEREAS, On March 07, 2022, a Senate Joint Resolution (SJR 13) was introduced by Senator Cortese urging the United States Congress, the Department of the Interior, and the Bureau of Indian Affairs to reaffirm and restore the Muwekma Ohlone Tribe as a federally recognized tribe and include the Muwekma Ohlone Tribe in the Federal Register as a recognized tribe; and

WHEREAS, Several California counties and elected officials have officially supported the Muwekma Ohlone Tribe in its efforts for recognition through legislation commending their efforts and historical and social accomplishments, supporting requests for historical claim by the Muwekma Ohlone Tribe, and urging the federal government to reaffirm and restore the Muwekma Ohlone Tribe as a federally recognized tribe; and

WHEREAS, Part of the Muwekma Ohlone Tribe's aboriginal and ethnohistoric territory includes San Francisco County; now, therefore, be it

RESOLVED, That the San Francisco Democratic Party supports the adoption of SJR 13 and calls on the Department of the Interior and the federal government to officially recognize the historical and social history of the Muwekma Ohlone Tribe by restoring the Muwekma Ohlone Tribe as a federally recognized tribe; and be it

FURTHER RESOLVED, That this Resolution be transmitted to the California State Legislature, the Senate Committee on Governmental Organization and office of Chair Dodd urging the committee to hear and vote to pass SJR 13 onto the full Senate for debate and, at the discretion of the Chair and Executive Board, to any subsequent legislative committees assigned to consider and act on SJR 13.

RESOLUTION NO. 2022-Ohlone Tribal Recognition

## RESOLUTION IN SUPPORT OF CALIFORNIA ABORTION PROVIDERS

WHEREAS, The United States Supreme Court's landmark decision in *Roe v. Wade* - which affirmed that everyone has a fundamental right to privacy including the right to obtain a safe and legal abortion - is at risk of being overturned or severely eroded; and

WHEREAS, Last year was the worst year for abortion access in recent history, with more than 106 abortion restrictions being enacted in 19 states, including 12 abortion bans; and twenty-six states are poised to ban abortion access in the event that *Roe v. Wade* is overturned or gutted impacting 36 million women and even more people who could become pregnant and a recent Guttmacher institute report shows there could be a 2,923 percent increase in out-of-state women of reproductive age who would find their nearest abortion provider in California if *Roe v. Wade* is overturned; and

WHEREAS, Providers of sexual and reproductive health care are still under attack for providing essential information and services, such as abortion as evidenced by bomb threats, arson, and vandalism in California and the fact that death threats against abortion providers nearly doubled, incidents of clinic invasion doubled, and bomb threats have nearly tripled nationally from 2018 to 2019 alone; now, therefore, be it

RESOLVED, That the San Francisco Democratic Party supports:

1. **Assembly Bill 1666** authored by Assembly Member Rebecca Bauer-Kahan which would declare another state's law authorizing a civil action against a person or entity that receives or seeks, performs or induces, or aids or abets the performance of an abortion, or who attempts or intends to engage in those actions, to be contrary to the public policy of this state, additionally the bill would prohibit the application of that law to a case or controversy heard in state court, and would prohibit the enforcement or satisfaction of a civil judgment received under that law; and
2. **Assembly Bill 2626** authored by Assembly Member Lisa Calderon which would prohibit the suspension or revocation of the certificate or license of a physician, surgeon, nurse practitioner, nurse-midwife, or a physician assistant solely for performing an abortion in accordance with the provisions the medical professional's governing board; and
3. **Assembly Bill 2091** authored by Assembly Member Mia Bonta which would prohibit compelling a person to identify or provide information that would identify an individual who has sought or obtained an abortion in a state, county, city, or other local criminal, administrative, legislative, or other proceeding if the information is being requested based on another state's laws that interfere with a person's right to choose or obtain an abortion or a foreign penal civil action; and be it

FURTHER RESOLVED, That this Resolution be transmitted to the California State Legislature and the offices of Assembly Members Bauer-Kahan, Calderon, and Bonta.

RESOLUTION NO. 2022-California Abortion Providers

## RESOLUTION IN SUPPORT OF ABORTION ACCESS IN CALIFORNIA

WHEREAS, The United States Supreme Court's landmark decision in *Roe v. Wade* affirmed that everyone has a fundamental right to privacy, self-determination, and the right to make their own reproductive decisions including allowing anyone who can become pregnant the right to decide when, if, and with whom to have children, how many children to have, and, if they so choose, to obtain a safe and legal abortion to terminate an unwanted pregnancy; and

WHEREAS, *Roe v. Wade* continues to protect the health and freedom of people throughout the United States, and national peer-reviewed studies show abortion is a safe medical procedure and is increasingly provided through outpatient medication, and that nearly one in four women in the United States will access an abortion at some point in their lives; however, prior to the *Roe v. Wade* decision, lack of access to safe and legal abortions cost pregnant people their health and their lives, deaths from unsafe abortions accounted for approximately 17 percent of all reported deaths attributable to pregnancy and childbirth, and many were severely injured as a result of unsafe abortion procedures; and

WHEREAS, By allowing for people to have more control over their reproductive lives, *Roe v. Wade* has helped further gender equity and facilitate more balanced economic and societal participation in the United States for all; now, therefore, be it

RESOLVED, That the San Francisco Democratic Party supports:

1. **Senate Bill 1142** authored by Senators Anna Caballero and Nancy Skinner which would establish the Abortion Practical Support Fund for the purpose of providing grants, upon appropriation by the Legislature, to assist pregnant people who are low income or face other financial barriers with access to abortions in California, and for research to support equitable access to abortion; and
2. **Assembly Bill 2134** authored by Assembly Members Akilah Weber and Cristina Garcia which would establish the California Reproductive Health Equity Program, a continuously appropriated fund, to provide grant funding to ensure abortion and contraception services are affordable for and accessible to all patients and to provide financial support for safety net providers of these services; and
3. **Assembly Bill 1918** authored by Assembly Member Petrie-Norris which would establish the California Reproductive Health Service Corps for the purposes of recruiting, training, and retaining a diverse workforce of reproductive health care professionals who will be part of reproductive health care teams to work in underserved areas; and be it

FURTHER RESOLVED, That this Resolution be transmitted to the California State Legislature and the offices of Senators Anna Caballero and Nancy Skinner, Assembly Members Akilah Weber, Cristina Garcia, and Cottie Petrie-Norris.

RESOLUTION NO. 2022- California Abortion Access

**RESOLUTION URGING SF PRIDE TO CONSIDER POLITICAL CONTRIBUTIONS TO ANTI LGBTQ CANDIDATES OR CAUSES IN ALLOWING CORPORATE PARTICIPATION IN PRIDE 2023**

WHEREAS, LGBTQ+ youth are among the most marginalized in our society, and as a result suffer from suicide rates four times higher than their peers, and the CDC found that in the first half of 2021, nearly half of LGBTQ+ teenagers considered committing suicide; now, in 2022, more than 300 pieces of anti-LGBTQ+ legislation have flooded statehouses across the country, among the most egregious examples are the now-infamous “Don’t Say Gay” bills passed in Florida and Alabama, as well as laws banning gender-affirming healthcare for minors in 5 states, closing clinics; these laws put 1 in 3 transgender minors at risk of losing access to life-saving healthcare, chill LGBTQ+ children’s ability to express themselves in school, and perpetrate real harm on families in these communities; and

WHEREAS, The politicians behind these laws are amplifying anti-LGBTQ bigotry, calling opponents of the bills “groomers” and “child abusers,” and this rhetoric has exacerbated harassment of LGBTQ+ people and precipitated a rise in violence against transgender people, and these politicians are gaining support for their bigotry from Republicans, while trans advocates say opposition to the bills from national allies has been weak or non-existent; and

WHEREAS, Dozens of major corporations who claim to support the LGBTQ+ community financially support the politicians behind these bills, and research by No Fake Allies and Data For Progress found that at least 118 Fortune 500 companies contributed to the campaigns of these bills’ sponsors since 2018; furthermore, at least 33 corporations who publicly sponsor various Pride celebrations across the country have made such contributions, and eight companies that took a pledge to oppose anti-LGBTQ+ legislation in the states have contributed to these anti-LGBTQ+ politicians; now, therefore, be it

RESOLVED, That the San Francisco Democratic Party (SFDCCC) stands unequivocally in solidarity with LGBTQ+ youth and opposes efforts to deny them access to proven suicide prevention measures such as instruction in LGBTQ+ issues in school, gender affirming healthcare, and participation in sports that align with their gender identity, and the SFDCCC urges all major corporations to freeze campaign contributions to politicians that repeatedly use bigoted anti-LGBTQ+ language and pursue policies that put LGBTQ+ youth at risk of suicide; and be it

FURTHER RESOLVED, That the SFDCCC calls on SF Pride to consider political giving in its criteria for allowing corporations to partner with or display official corporate logos at SF Pride beginning in 2023.
