## RESOLUTION IN SUPPORT OF COMPLIANCE OF SB NO. 826, REQUIREMENT FOR WOMEN TO BE ON BOARDS, THE GENERAL CORPORATIONS LAW

Sponsors: Berry, Lovett, Morales, Ronen, Ibáñez, Baraka, Mahogany, Gallotta, Loftus, Chen, and Williams

WHEREAS, SB NO. 826 was passed by Governor Jerry Brown September 30, 2018. This bill, no later than the close of the 2019 calendar year, would require a domestic general corporation or foreign corporation that is a publicly held corporation, as defined, whose principal executive offices, according to the corporation's SEC 10-K form, are located in California to have a minimum of one female. No later than the close of the 2021 calendar year, then would increase that required minimum number to 2 female directors if the corporation had 5 directors or to 3 female directors if the corporation has 6 or more directors.

WHEREAS, Some Corporations have complied, according to Morgan, Lewis & Bockius LLp, a new report shows that the number of women on California corporate boards has increased 66.5% since 2018 after the state required corporations to have at least one to three female directors by 2021.

WHEREAS, According to the California Secretary of State annual report in March of 2021, several Corporations are not in compliance.

BE IT RESOLVED, The San Francisco Democratic County Central Committee supports and encourages the California Secretary of State to impose fines for violations of the bill in accordance with SB 826.

BE IT FURTHER RESOLVED, that the SF DCCC, Executive Director shall send a copy of this Resolution to the California Secretary of State.
