

## **RESOLUTION IN SUPPORT OF AB 228, INFANT FORMULA STOCKPILE**

WHEREAS, The PUMP Act for Nursing Mothers Act (S 1658/H.R. 3110), signed into law on December 29, 2022, makes several important changes to The Break Time for Nursing Mothers law, passed in 2010: Provides the right to break time and space to pump breast milk at work to millions more workers, including teachers and nurses, makes it possible for workers to file a lawsuit to see monetary remedies in the event that their employer fails to comply and clarifies that pumping time must be paid if an employee is not completely relieved from duty; and

WHEREAS, The PUMP Act initially failed to pass the Senate in June 2022 during the height of the formula shortage; and

WHEREAS, The shutdown of the Sturgis plant demonstrated the fragility of the formula market to supply shocks: formula prices increased by an average of 11 percent between March 2021 and May 2022 and shortages spiked to over 74 percent nationwide at the end of May 2022, with ten states having shortage levels of 90 percent or greater; now, therefore, be it

RESOLVED, That the San Francisco Democratic County Central Committee encourages the California State Assembly to pass Assembly Bill 228, an act to add Section 131022 to the Health and Safety Code, relating to public health. This bill would require the State Department of Public Health and the Office of Emergency Services, in coordination with other state agencies as appropriate to, upon appropriation and as necessary, establish an infant formula stockpile; and, be it

RESOLVED, That the San Francisco Democratic Party commends all of the volunteers who made GOTV calls at the Keep it Blue office during the 2022 midterm election cycle and conveys our deep appreciation for their dedication, passion, energy, and perseverance to do the hard, unsung work to keep the health of our democracy strong; and, be it

FURTHER RESOLVED, That the San Francisco Democratic Party expresses its sincere thanks to our Speaker Emerita Nancy Pelosi and Team Pelosi for establishing the Keep it Blue office in 2022, providing this critical democratic infrastructure for San Francisco Democrats for multiple election cycles since 2018, and for making the space available for striking Starbucks workers and other labor actions honoring the Speaker's slogan: "We don't agonize, we organize, and we unionize."

## **RESOLUTION IN SUPPORT OF SF JANITORS FIRED FROM TWITTER BUILDING**

WHEREAS, Contracted janitors who cleaned Twitter's offices went on an unfair labor practice strike following Twitter's announcement that their cleaning company's contract would not be renewed, leaving 48 janitors out of work over two rounds of layoffs just three weeks before Christmas; and

WHEREAS, The union representing the affected Janitors, SEIU Local 87, has alerted Twitter that state and local laws require incoming contractors to retain the employees of outgoing contractors for at least 60 days; and

WHEREAS, The fired janitors were left without salary, severance, or healthcare and join a growing list of workers who have lost their jobs at Twitter's offices over the last few weeks, including contracted culinary workers and thousands of the company's own employees; now, therefore, be it

RESOLVED, That the San Francisco Democratic County Central Committee strongly supports the members of SEIU Local 87, who are calling on Twitter to do the right thing and bring back the workers who were laid off, correcting the devastating disruption of abruptly losing their income and healthcare coverage just before the holidays; and be it

FURTHER RESOLVED, That copies of this Resolution be sent to the offices of Shorenstein Properties, JP Morgan, SF BOMA, Twitter Inc., SEIU Local 87, the San Francisco Labor Council, and the California Democratic Party.
